This Market Making agreement is made and entered into Ahmedabad on this **May 16, 2023** by and among:

1. AHASOLAR TECHNOLOGIES LIMITED, a Company incorporated under the Companies Act, 2013 and having its registered office at Office No. 207, Kalasagar Shopping Hub Opp. Saibaba Temple Sattadhar Cross Rd Ghatlodiya Ahmedabad Ahmedabad GJ 380061 IN (hereinafter refer to as "ATL" or "Issuer Company") which expression shall, unless it be repugnant the context or meaning thereof be deemed to mean and include its successor; and permitted assigns, of the FIRST PART;

AND

2. SUNFLOWER BROKING PRIVATE LIMITED, a company incorporated under Companies Act, 1956 and having its office at office at 5th Floor, Sunflower House, Near Bhakti Nagar Circle, Bhakti Nagar, Rajkot-360002, Gujarat (hereinafter referred as "SBPL" or and "Market Maker") which expression shall, unless it be repugnant to the context or meaning deemed to mean and include its successors and permitted assigns of the SECOND PART.

AND

3. BEELINE CAPITAL ADVISORS PRIVATE LIMITED, having its registered office at B/1311-1314, Shilp Corporate Park Near Rajpath Club, Rajpath Rangoli Road, Sarkhej - Gandhinagar Hwy, Ahmedabad, Gujarat 380054 (hereinafter referred to as "The Merchant Banker" or "BCAPL" or "Lead Manager") which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include its successors and permitted assigns.

In this market making agreement, Issuer Company, Market Maker and Lead Manager are hereinafter collectively referred to as the "Parties" and individually as a "Party".

WHEREAS:

- The Issuer Company proposes to issue 8,18,400 Equity Shares of the Company of face value Rs. 10/- each in accordance with the Chapter IX of SEBI (ICDR) Regulations, 2018 at an Issue Price of Rs.
 [•] per Equity Share aggregating to Rs. [•] lakhs ("Fresh Issue/Issue/Public Issue").
- 2. The Equity Shares to be allotted in this Public Issue comprises a net issue to the public of 7,76,000 Equity Shares ("Net Issue") of the Company of face value Rs. 10/- each at an Issue Price of Rs. [•]/- each per Equity Share (including securities premium of Rs. [•] Each) aggregating to Rs. [•] lakhs and reserved portion for the Market Maker aggregating 42,400 Equity Shares of the Company of face value Rs. 10/- each at an Issue Price of Rs. [•] each per Equity Share aggregating to Rs. [•]. The net issue to public shall comprise of issue to Retail Individual Investors and other Investors.
- 3. The Board of Directors of the Company (the "Board"), in their meeting held on January 06, 2023 has approved the Fresh Issue. Further, the Fresh Issue has been approved by a special resolution adopted pursuant to Section 23 and 62(1)(c) of the Companies Act, 2013 at the extra-ordinary general meeting of the shareholders of the Company held in January 06, 2023. The Board of Directors of the Company (the "Board") which are collectively authorised or any other authorised representatives, for the purpose of the Issue, to issue and sign the Draft Prospectus, the Prospectus, this Agreement, the Market Making Agreement (as defined hereunder), Underwriting Agreement (as defined hereunder), any amendments or supplements thereto, and any and all other writings as may be







- legally and customarily required in pursuance of the Issue and to do all acts, deeds or things as may be required.
- 4. The Issuer Company has entered into an Underwriting agreement dated May 16, 2023 with the Lead Manager where under the Lead Manager will be underwriting 8,18,400 Equity shares which includes 42,400 Equity Shares of the Market Maker Reservation portion which are to be subscribed by the Market Maker in order to claim compliance with the requirements of Regulation 261 of the SEBI (ICDR) Regulations, 2018.
- 5. The Issuer Company had applied for the In-principle approval with BSE Limited (BSE SME) for listing of Equity Shares on their SME Platform and for including name of BSE Limited in the offer document and the BSE vide its letter dated [•] granted / approved the same.
- 6. One of the requirements for issuing shares to the public in accordance with Chapter IX of the SEBI (ICDR) Regulations, as specified in Regulation 261 of the SEBI (ICDR) Regulations, is that a merchant banker to the public issue has to ensure compulsory Market Making through the stock brokers of the SME Exchange(s) appointed by the issuer during the compulsory Market Making Period.
- SUNFLOWER BROKING PRIVATE LIMITED is a registered market maker and registered broker of both nationwide Stock Exchanges i.e. BSE Limited and National Stock Exchange of India Limited having SEBI registration No INZ000195131.
- 8. SUNFLOWER BROKING PRIVATE LIMITED has agreed to offer 'market making' on the terms and conditions specified in this Agreement.

NOW TEHREFORE, this Agreement, witnesses, the terms and conditions agreed upon by the Market Marker, Issuer Company and the Lead Manager for the market making of the equity shares of the Issuer







Company, as specified in the SEBI Regulations and the requirements of the Stock Exchange.

1. DEFINITIONS AND INTERPRETATIONS:

1.1. In this Agreement unless the context otherwise requires:

"Affiliates" with respect to any person means (a) any other person that, directly or indirectly, through one or more intermediaries, Controls or is Controlled by or is under common control with such person, (b) any other person which is a holding company or subsidiary of such person, and/or (c) any other person in which such person has a "significant influence" or which has "significant influence" over such person, where "significant influence" over a person is the power to participate in the management, financial or operating policy decisions of that person but is less than Control over those policies and that shareholders beneficially holding, directly or indirectly through one or more intermediaries, a 10% or higher interest in the voting power of that person are presumed to have a significant influence over that person. For the purposes of this definition, (i) the terms "holding company" and "subsidiary" have the meaning set forth in Companies Act, 2013.

"Allotment" shall mean the issue and allotment of Equity Shares pursuant to the Public Issue.

"Agreement" shall mean this agreement or any other agreement as specifically mentioned.

"Applicant" shall mean any prospective investor who makes an application for Equity Shares in terms of the Prospectus.

"Application" shall mean an indication to make an offer during the period starting from issue opening date and issue closing date by prospective investor to subscribe to the Equity shares at the Issue Price including all revisions and modifications thereto.

"Stock Exchange/Designated Stock Exchange" shall mean BSE Limited (BSE).

"Companies Act" shall mean the Companies Act, 2013, as amended from time to time.

"Compulsory Market Making Period" shall mean the period of three years commencing on the date of listing of the Equity Shares of the company as prescribed under the SEBI Regulations.

"Controlling", "Controlled by" or "Control" shall have the same meaning ascribed to the term "control" under the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011, or as amended.

"Controlling Person(s)" with respect to a specified person, shall mean any other person who Controls such specified person.

"Draft Prospectus" shall mean the Draft Prospectus of the Company which will be filed with Stock Exchange in accordance with Section 26 of the Companies Act;

"**Equity Shares**" means the equity shares in the share capital of the Issuer Company.

"Force Majeure Event" shall mean:

- a) a complete break down or dislocation of business in the major financial markets affecting any or all of the cities of New Delhi, Ahmedabad, Mumbai, Kolkata, Chennai as a result of which the success of the Issue is likely to be prejudicially affected;
- b) declaration of war or occurrence of insurrection, civil commotion or any other serious or sustained financial, political or industrial emergency or disturbance affecting the financial markets in any or all of the cities of New Delhi, Ahmedabad, Mumbai, Kolkata and Chennai as a result of which the success of the Issue is likely to be materially and adversely affected; or

c) any material adverse change in the international financial or political conditions as a result of which trading generally on the Stock Exchange is suspended for a continuous period of more than 2 (two) Business Days or future trading on the Stock Exchange is likely to be materially limited or restricted as a result of which the success of the Issue is likely to be materially and adversely affected.

"Indemnified Party" shall have the meaning given to such term in this Agreement.

"Indemnifying Party" shall have the meaning given to such term in this Agreement.

"Issue Price" means Rs. [•]/- per Equity Share.

"Lead Manager" means Lead Manager to the Issue, in this case, Beeline Capital Advisors Private Limited having SEBI Registration INM000012917.

"Listing Date" shall mean the date with effect from which the Equity Shares issued through this Public Issue being made are listed for trading by the SME Platform of Stock Exchange.

"Market Maker Reservation Portion" shall mean the reserved portion for the Market Maker aggregating 42,400 Equity Shares of Rs. 10/- each at for cash at a price of Rs.[•]/- per share (THE "ISSUE PRICE") aggregating to Rs.[•].

"Material Adverse Effect" shall mean, individually or in the aggregate, a material adverse effect on the condition, financial or otherwise, or in the earnings, business, management, operations or prospects of the Company and its subsidiaries, taken as a whole.

"Memorandum of Understanding" shall mean the memorandum of understanding dated March 28, 2023 entered into between the Issuer Company and Lead Manager.

"Net Issue" shall mean fresh issue of equities shares, Shares to be Allotted in this Public Issue comprising of 7,76,000 Equity Shares of Rs. 10/- each for cash at a price of Rs. [•]/- per share (THE "ISSUE PRICE") aggregating to Rs. [•]

"Public Issue" shall mean issue of 8,18,400 Equity Shares having face value of Rs. 10/- each in accordance with the Chapter IX of SEBI (ICDR) Regulations, 2018 and applicable Indian securities laws at an Issue Price of Rs. [•]/- per Equity Share aggregating to Rs. [•] lakhs.

"Party" or "Parties" shall have the meaning given to such terms in the preamble to this Agreement.

"Prospectus" shall mean the Prospectus to be filed in terms of the applicable provisions of the Companies Act with the Registrar of the Companies (ROC) and the Stock Exchange (i.e. Designated Stock Exchange) containing inter-alia, basis of allotment and certain other information;

"SEBI" shall mean Securities and Exchange Board of India constituted under the Securities and Exchange Board of India Act, 1992; and

"SEBI Regulations" or "SEBI (ICDR) Regulations" or "ICDR Regulations" shall mean the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations 2018 and the circulars and directions issued by SEBI in relation to the issue or market marking, as applicable.

"SME/Emerge Platform of Stock Exchange" shall mean the separate platform on the Stock Exchange, for listing Company's equity shares in terms of Chapter IX of the SEBI (ICDR) Regulations, in this case, SME Platform of BSE Limited ("BSE SME").

"Underwriter" means underwriter to the issue, in this case, Beeline Capital Advisors Private Limited having SEBI Registration INM000012917.

- 1.2. In this Agreement, unless the context otherwise requires:
- a) words denoting the singular shall include the plural and vice versa;
- words denoting a person shall include an individual, corporation, company, partnership, trust or other entity;
- headings and bold typeface are only for convenience and shall be ignored for the purposes of interpretation;
- references to the word "include" or "including" shall be construed without limitation;
- e) references to this Agreement or to any other agreement, deed or other instrument shall be construed as a reference to such agreement, deed, or other instrument as the same may from time to time be amended, varied, supplemented or noted;
- reference to any party to this Agreement or any other agreement or deed or other instrument shall, in die case of an individual, include his or her legal heirs, executors or administrators and, in any other case, include its successors or permitted assigns;
- g) a reference to an article, section, paragraph or schedule is, unless indicated to the contrary, a reference to an article, section, paragraph or schedule of this Agreement;
- h) reference to a document includes an amendment or supplement to, or replacement or notation of, that document; and
- i) Terms used in this Agreement and not specifically defined herein shall have the meanings given to such terms in the Underwriting Agreement, Draft Prospectus and the Prospectus as the context requires.
- 1.3. The Parties acknowledge and agree that the Schedules attached hereto form an integral part of this Agreement.







2. MARKET MAKING

- 2.1. On the basis of the representations and warranties contained in this Agreement and subject to the terms and conditions herein, the Market Maker hereby agrees to;
- a. Subscribe to 42,400 equity shares being the market maker reservation portion as specified in the Prospectus, on a firm basis and pay the amounts as are specified in the Prospectus. The Market Maker agrees not to withdraw its application.
- b. Ensure Market Making in the Equity Shares of Ahasolar Technologies Limited in the manner and on the terms and conditions contained this Agreement, and as specified by SEBI and Stock Exchange from time to time.
- 2.2. The Market Maker shall be required to provide a 2-way quote for 75% of the time in a day. The same shall be monitored by the stock exchange. Further, the Market Maker(s) shall inform the exchange in advance for each and every black out period when the quotes are not being offered by the Market Maker.
- 2.3. The prices quoted by the Market Maker shall be in compliance with the requirements and other particulars as specified by the SME Platform of Stock Exchange and SEBI from time to time.
- 2.4. The minimum depth of the quote shall be Rs. 100,000/- However, the investors with holdings of value less than Rs. 100,000/- shall be allowed to offer their holding to the Market Maker in that scrip provided that he sells his entire holding in that scrip in one lot along with a declaration to the effect to the selling broker.
- 2.5. The Market Maker shall not sell in lots less than the minimum contract size allowed for trading on the SME Platform of Stock Exchange (in this case currently the minimum trading lot size is







- [•] Equity Shares; however, the same may be changed by the SME Platform of Stock Exchange from time to time).
- 2.6. After a period of three (3) months from the market making period, the market maker would be exempted to provide quote if the Shares of market maker in our Company reaches to 25% of Issue Size (Including the 42,400 Equity Shares out to be allotted under this Issue.) Any Equity Shares allotted to Market Maker under this Issue over and above 42,400 Equity Shares would not be taken in to consideration of computing the threshold of 25% of Issue Size. As soon as the Shares of market maker in our Company reduce to 24% of Issue Size, the market maker will resume providing 2-way quotes.
- 2.7. There shall be no exemption/threshold on downside. However, in the event the Market Maker exhausts his inventory through market making process, Stock Exchange may intimate the same to SEBI after due verification.
- 2.8. Execution of the order at the quoted price and quantity must be guaranteed by the Market Maker for the quotes given by him.
 Market Maker shall not buy the Equity Shares from the promoters or persons belonging to promoter group of the Issuer Company or any person who has acquired Equity Shares from such promoter or person belonging to promoter group, during the Compulsory
- 2.9. There will not be more than five Market Makers for the Equity Shares and the Market Makers may compete with other Market Makers for better quotes to the investors.

Market Making Period.

2.10. The Market Maker shall not be responsible to maintain the price of the Equity Shares of the Issuer Company at any particular level and is purely supposed to facilitate liquidity by offering its 2-way





- quotes. The price of the shares shall be determined and be subject to market forces.
- 2.11. The shares of the Company will be traded in continuous trading session from the time and day the company gets listed on SME Platform of Stock Exchange and Market Maker will remain present as per the guidelines mentioned under Stock Exchange and SEBI circulars.
- 2.12. The Marker maker may also be present in the opening call auction, but there is no obligation on him to do so.
- 2.13. There will be special circumstances under which the Market Maker may be allowed to withdraw temporarily/fully from the market for instance due to system problems, any other problems. All controllable reasons require prior approval from the Stock Exchange, while force-majeure will be applicable for non controllable reasons. The decision of the Stock Exchange for deciding controllable and non-controllable reasons would be final.
- 2.14. Risk containment measures and monitoring for Market Makers: Stock Exchange will have all margins which are applicable on the Stock Exchange's Main Board viz., Mark-to-Market, Value-At-Risk (VAR) Margin, Extreme Loss Margin, Special Margins and Base Minimum Capital etc. Stock Exchange can impose any other margins as deemed necessary from time-to-time.
- 2.15. Punitive Action in case of default by Market Makers: Stock Exchange will monitor the obligations on a real time basis and punitive action will be initiated for any exceptions and/or non-compliances. Penalties / fines may be imposed by the Stock Exchange on the Market Maker, in case he is not able to provide the desired liquidity in a particular security as per the specified guidelines. These penalties / fines will be set by the Stock Exchange from time to time. The Stock Exchange will impose a

penalty on the Market Maker in case he is not present in the market (offering two-way quotes) for at least 75% of the time. The nature of the penalty will be monetary as well as suspension in market making activities / trading membership.

The Department of Surveillance and Supervision of the Stock Exchange would decide and publish the penalties / fines / suspension for any type of misconduct/ manipulation/ other irregularities by the Market Maker from time to time.

2.16. Additionally, the trading shall take place in TFT segment for first 10 days from commencement of trading. The following spread will be applicable on the Stock Exchange's SME Platform.

2.17. After completion of the first three months of market making, in terms of SEBI Circular No. CIR/MRD/DSA/31/2012 dated November 27, 2012; the Market Maker shall be exempt from providing buy quote on attaining the prescribed threshold limits (including the mandatory allotment of 5% of Equity Shares of the Offer). Further, the Market Maker can offer buy quotes only after the Market Maker complies with prescribed re-entry threshold limits. Only those Equity Shares which have been acquired by the Market Maker on the SME Platform of BSE Limited ("BSE SME") during market making process shall be counted towards the Market Maker's threshold. The Market Maker shall be required to provide two-way quotes during the first three months of the market making irrespective of the level of holding

2.18. Price Band and Spreads: SEBI Circular bearing reference no: CIR/MRD/DP/02/2012 dated January 20, 2012, has laid down

that for issue size up to Rs. 250 crores, the applicable price bands for the first day shall be:

- In case equilibrium price is discovered in the Call Auction, the price band in the normal trading session shall be 5% of the equilibrium price.
- ii. In case equilibrium price is not discovered in the Call Auction, the price band in the normal trading session shall be 5% of the issue price.

Additionally, the trading shall take place in TFT segment for first 10 days from commencement of trading. The price band shall be 20% and the market maker spread (difference between the sell and the buy quote) shall be within 10% or as intimated by Exchange from time to time. The call auction is not applicable of those companies, which are listed at SME platform.

2.19. Pursuant to SEBI Circular number CIR/MRD/DSA/31/2012 dated November 27, 2012, limits on the upper side for market makers during market making process has been made applicable, based on the issue size and as follows:

- it will comply with all of its respective obligations set forth in this Agreement;
- d) it shall ensure compliance with the applicable laws and rules laid down by SEBI and the Stock Exchange with respect to its role of the Lead Manager in the Market Making process in general and Market Making process in the Equity Shares of the Issuer Company in specific;

- authority that, in the judgment of the Market Maker, is material and adverse and that makes it, in the judgment of the Market Maker, impracticable to carry out market making.
- Issuer Company contained in this Agreement shall be true and correct on and as of the Listing Date and both these parties shall have complied with all the conditions and obligations under this Agreement and the Underwriting Agreement on its part to be performed or satisfied on or before the Listing Date.
- c) The Market Maker shall have received evidence satisfactory to them that the Equity Shares have been granted final listing approval by the Stock Exchange on SME Platform on dated [•] and that such approvals are in full force and effect as of the Listing Date.
- d) Subsequent to the Listing Date and without having served the notice period required to terminate this agreement, the Market Maker shall not be released from its obligations in any situation, except for technical failure or Force Majeure Event. In case of technical failure or force majeure event occurring due to the Market Maker's own system, the Market Maker shall inform the Lead Manager, Issuer Company and the Stock Exchange immediately and take necessary actions to correct this failure upon discovery.

10. TIME IS THE ESSENCE OF AGREEMENT

The arbitration shall take place in Ahmedabad, India.

The Arbitrator shall give a reasoned decision or award, including as to the costs of the arbitration, which shall be final and binding on the Parties. The Parties agree that the Arbitrator's award may be enforced against the Parties to the proceedings or their assets, wherever they may be found. The Parties shall co-operate in good faith to expedite (to







the maximum extent practicable) the conduct of any arbitral proceedings commenced under this Agreement. Each Party shall bear and pay its own costs, expenses, fees, disbursements and other charges of its counsel, in connection with the arbitration proceedings except as may be otherwise determined by the Arbitrator.

Any reference of any dispute, difference or claim to arbitration under this Agreement shall not affect the performance by the Parties of their respective obligations under this Agreement other than the obligations relating to the dispute, difference or claim referred to arbitration.

15. AMENDMENT

No amendment, supplement, modification or clarification to this Agreement shall be valid or binding unless set forth in writing and duly executed by all the Parties to this Agreement.

16. SEVERABILITY
